No.1/1/2007/DMOBC:- It is hereby notified for general information that the Ministry of Minority Affairs, Government of India has introduced a Scheme of Merit-cum Means based Scholarship for students belonging to the minority communities (Muslims and Christians) for Technical and Professional Courses at under-graduate and post-graduate levels which is a centrally sponsored scheme, funded entirely by the Central Government and will be implemented through the State Government's administrations during the Eleventh Five Year Plan beginning 2007-08.

Therefore, the Department for Welfare of Minorities & Other Backward Classes, Manipur invites applications for award of the abovementioned Scholarship in the prescribed format from the intending students belonging to Minority Christians and Muslim communities domiciled in the State of Manipur.

Application Forms can be had from the Directorate of Welfare of Minorities & Other Backward Classes, Manipur on all working days and forms can also downloaded from the web site, http://Manipur.nic.in/Mobc.htm.

Duly filled in application forms should be submitted to the Director, Welfare of Minorities & Other Backward Classes, Govt. of Manipur.

Last date for submission of application forms is on 15th September, 2007.

The following is the eligibility criteria for applying the scholarship:-

- (i) Students, who have got admission in a recognized college to pursue technical/professional courses, on the basis of a competitive examination.
- (ii) Students, who have got admission in a recognized college to pursue technical/professional courses, without facing any examination, will also be eligible for scholarship. However, such students should secure not less that 50% marks at higher secondary/graduation level.
- (iii) Selection of students will strictly be done on merit.
- (iv) A scholarship holder under this scheme will not avail any other scholarship/stipend for pursuing the course.
- (v The annual family income of the beneficiary/parents or guardian of the beneficiary should not exceed Rs. 2.50 lakh per annum from all sources.
- (vi) A students residing in a particular State/UT will be entitled for scholarship under the quota of that State/UT only irrespective of his place of study.
- (vii) Continuation of the scholarship in subsequent years will depend on successful completion of the course during the preceding year.
- (viii) 30% of scholarship will be reserved for girls students of each which is transferable to male students in the case of non-availability of female candidates.
- (ix) The Scholarship will not be paid for the period of internship/housemanship in the case of MBBS course or for a practical training in other course if the student is in receipt of some remuneration during the internship period or some allowance/stipend during the practical training on other course.

PROCEDURE FOR APPLYING THE SCHOLARSHIP:-

The application for scholarship should comprise:-

- (i) One copy of the application for scholarship in the prescribed form (separate application forms prescribed for "fresh" and renewal of scholarship by the concerned States.
- (ii) One copy of the passport size photograph with signatures of the students thereon (for fresh scholarship).
- (iii) One attested copy of certificates, diploma, degree etc. in respect of all examinations passed.
- (iv) An income declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper.
- (v) Proof of permanent residence.
- (vi) The scholarship is depended on the satisfactory progress and conduct of the scholar. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc. the authority sanctioning the scholarship may either cancelled the scholarship or stop or withhold further payment for such period as it may think fit.
- (vii) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The students concerned will be blacklisted and debarred for scholarship in any scheme forever.
- (viii) A scholarship awarded may be cancelled if the scholar changes the subject of the course of study for which the scholarship was originally awarded or changes the Institution of study, without prior approval of the State Government. The Head of the Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.
- (ix) A scholar is liable to refund the scholarship amount at the discretion of the State Government, if during the course of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.
- (x) The regulations can be changed at anytime at the discretion of the Government of India.
- (xi) The Quota of the Scholarship for the State of Manipur is **20 (twenty) for Muslim Students and 78 (seventy-eight) for Christian students.**
