GENERAL:

- The performance of the service will be dependent on the bandwidth of the IP or ISDN line used by the participants using the service and any drop in the bandwidth due to this will not be under the discretion of BSNL.
- Customers are free to use any video camera which is ITU-T H.320/H.323 compliant.
- The service is offered to the existing BSNL subscribers only.
- The subscriber is required to fully comply with the provisions contained in the Indian Telegraph Act 1885, Indian Telegraph Rules and the Information Technology Act 2000 and any amendments or replacements made thereto from time to time.

OTHERS:

- The service will be activated within 15 days of the form submission at the Customer Service Center.
- The payment can be done by Cash/Cheque/DD. Cheque/DD payment is considered as paid subject to realization.
- The service offerings are under the full discretion of BSNL and are subject to change.
- Billing will be done separately for this service.

RIGHT TO TERMINATE SERVICES:
