Terms and Conditions

GENERAL:

- Customers are free to use any standard Web camera with resolution of at least 300K pixels. Pl note higher resolution cameras will consumer higher bandwidth.
- The service is offered to active BSNL Broadband subscribers.
- The subscriber is required to fully comply with the provisions contained in the Indian Telegraph Act 1885, Indian Telegraph Rules and the Information Technology Act 2000 and any amendments or replacements made thereto from time to time.

OTHERS:

- The service will be provisioned within 15 days of the form submission at the Customer Service Center.
- The payment can be done by Cash/Cheque/DD. Cheque/DD payment is considered as paid subject to realization.
- The service offerings are under the full discretion of BSNL and are subject to change.
- Billing will be done separately for this service.

RIGHT TO TERMINATE SERVICES:
